2. Pursuant to the aforementioned advertisement notification an OMR Based Objective Type Written Test for the selection of candidates to the 1889 posts of Accounts Assistant (Panchayat) was held on 10.11.2020 and based on the performance of the candidates in the Objective Type Test, the result/Score sheet was notified vide Notice No. SSB/Secy/Sel/2020/5145-55 dated 25.12.2020. Subsequently, the Jammu and Kashmir Services Selection Board prepared a shortlist of candidates and thereafter the shortlisted candidates were called for Document Verification vide Order No. 07-SSB of 2021 dated 06.01.2021 and document verification of shortlisted candidates was conducted w.e.f. 08.01.2021 to 09.02.2021. In respect of physically handicapped candidates, (07) Special Medical Boards were got constituted by the Health and Medical Education Department and PwD candidates were called upon to appear before the Medical Boards on 29th and 30th of March, 2021 and 23rd and 24th of April, 2021. In the meantime, the Social Welfare Department vide Government Order No. 59-JK(SWD) of 2021 dated 15.04.2021 identified posts suitable for additional 1% disability notified under new Reservation Rule issued by S.O.127 dated 20.04.2020.

3. It was laid down in the Advertisement Notification No. 02 of 2020 dated 06.07.2020 at para 9 that the Services Selection Board shall make allocation of the District cadre in favour of successful candidates on the basis of "Merit Cum Preference" Method. The preferences from the candidates were obtained at the time of filling in of online application forms.

4. During the preparation of Selection List, the Board was confronted with the issue of allocating Districts in favour of those meritorious reserved category (MRC) candidates who though meritorious were unable to be considered under Open Merit for allocation of Districts of their preference/choice and in comparison less meritorious candidates of the reserved category were likely to get allocated to the Districts of their first preference against reserved category posts, thereby leading to an anomalous situation. Accordingly, it was deemed expedient to take up the matter with the General Administration Department for consultation and advice in the matter.

5. The General Administration Department after consulting Department of Law, Justice and Parliamentary Affairs vide communication No GAD/MTG/RBIV/15/2021/02/GAD dated 08.05.2021 advised this office that the meritorious reserved category (MRC) candidates unable to get allocated to the district of their choice in the Open Merit, be considered against reserved category for allocation of district so that he/she may not be placed at a disadvantageous position as compared to lower merit reserved category candidates. The Department of Law, Justice and Parliamentary Affairs relied upon the judgments of Hon'ble Supreme Court in the cases titled Yoganand Vishwasrao Patil Vs. State of Maharashtra, 2005 (12) SCC 311, Retesh R Shah Vs. Dr. Y.L.Yamul (1996) 3 SCC 253, Anurag Patel Vs. UP Public Service Commission 2005 (9) SCC 72, AIR 2005 SC 1262.

6. On the basis of opinion rendered by the Department of Law, Justice and Parliamentary Affairs read with Jammu and Kashmir Reservation Rules, 2005 notified vide SRO 294 and pursuant to the recommendations of the Selection Committee constituted for the purpose, the Jammu and Kashmir Services Selection Board notified a Provisional Selection List-Cum- Allocation of Districts in favour of the selected candidates vide No. SSB/Secy/Sel/2021/3765-75 dated 10.05.2021. An opportunity was provided to the candidates to file representations/objections against the notification dated 10.05.2021 through online mode.

7. In this context, numerous representations were received by the Board with following major contentions: -

- i. Candidates whose recommendations were kept withheld for want of certain documents/clarifications sought release thereof.
- ii. Approximately 150 number of candidates sought change in allocation of districts on mutual basis or otherwise.
- iii. It was contended that Horizontal reservations in respect of PwD and ESM candidates ought to have been done category wise in a compartmentalized manner.
- iv. Some candidates requested for issuance of waiting list alongwith the Selection List.
- v. Some candidates contended that in certain cases candidates having lower merit were allocated districts of more preferred district in comparison to more meritorious candidates.
- vi. Certain candidates raised the grievance that posts falling under Open Merit category in some districts have been allocated to (reserved category) candidates.

8. In the meanwhile, the Jammu and Kashmir Services Selection Board again took up the matter with the General Administration Department for seeking additional clarifications with regard to allocation of preferred districts to MRC Candidates against reserved category posts and consequent availability and filling up of unoccupied/leftover Open Merit posts in respect of some other districts.

9. The General Administration Department vide their communication No. MTGORBIV/15/2021-02-GAD dated 01.07.2021 after consulting the Department of Law, Justice and Parliamentary Affairs conveyed the following advice/opinion: -

"The law laid down by the Apex Court in Tripurari Sharan v. Ranjit Yadav can be taken as a guiding factor in such situation. Therefore, it is in this context, the relevant para is quoted herein below: 14. In light of the cases discussed herein above, both questions are answered as follows: 1) A MRC can opt for a seat earmarked for the reserved category, so as to not disadvantage him against less meritorious reserved category candidates. Such MRC shall be treated as part of the general category only. i) Due to the MRC's choice, one reserved category seat is occupied, and one seat among the choices available to general category candidates remains unoccupied. Consequently, one lesser-ranked reserved category candidate who had choices among the reserved category is affected as he does not get any choice anymore. To remedy the situation i.e. to provide the affected candidate a remedy, the 50th seat which would have been allotted to X- MRC, had he not opted for a seat meant for the reserved category to which he belongs, shall now be filled up by that candidate in the reserved category list who stands to lose out by the choice of the MRC. This leaves the percentage of reservation at 50% undisturbed. In view of the above, it is quite pertinent to mention here that in any case ratio of 50:50 is required to be maintained while making selection/appointment on merit/choice basis".

10. The above said representations were examined by the concerned Selection Committee in light of the factual position, opinion rendered by the Department of Law, Justice and Parliamentary Affairs together with the rules governing the field and subsequently furnished its recommendation for consideration of the Board. In some cases, the Hon'ble Central Administrative Tribunal had given directions to the Jammu and Kashmir Services Selection Board to dispose of the representations before the release of recommendation. All such representations were disposed of by the Board on merits and the directions issued by the CAT were complied with in letter and spirit.

11. In light of the aforementioned opinions of the General Administration Department together with factual position and rules governing the field, the Selection Committee prepared the final Selection List/Allocation of Districts in respect of selected candidates. The same was considered by the Board in its 184th meeting held on 02.07.2021 and it was decided to release the Final Selection List/Allocation of Districts in respect of selected candidates for the post of Accounts Assistant (Panchayat). The Final Selection List/Allocation of Districts in respect of selected candidates for 1889 posts of Accounts Assistant (Panchayat) was notified vide notification No. SSB/Secy/Sel/2021/4791-4800 dated 03.07.2021. Accordingly, the District-wise Final Selection List of Accounts Assistant (Panchayat) is enclosed herewith as annexure-"A" to "T" for issuance of appointment orders in accordance with relevant rules.

12. Further, the list notified shall be subject to the outcome of writ petition (s) (if any) pending disposal before any competent Court of jurisdiction related to the selection.

13. The document verification/ scrutiny conducted by the Board is limited to the extent of establishing physical possession of category/degree genuineness/validity or otherwise of the same shall be responsibility of the Indenting Department/appointing authority.

14. You are further requested that in case any certificate/document, during the course of verification, turns out to be fake/fictitious, the Board may kindly be kept posted and appropriate criminal proceeding against such candidates may kindly be intimated. The waiting list shall be issued subsequently.

15. The selection list is also available on the website of the J&K Services Selection Board (www.jkssb.nic.in) and may be cross verified from it, if required.



The offer of appointment is provisional and subject to being found suitable for appointment in Government service and further subject to verification of your character & antecedents and other relevant documents.

2. In addition to basic pay in Level-10 of Pay Matrix [₹56,100-₹1,77,500], you will be entitled to draw dearness and other allowances at the rates admissible and subject to the conditions laid down in rules/ orders governing grant of such allowances.

3. Your **appointment is temporary** but likely to become permanent on successful completion of your probation period. Your claim for permanent appointment in JTS of the service will be considered in accordance with the ISS Rules, 2016 as amended from time to time.

4. You will be on probation for a period of **two years** from the date of your joining. The period of probation may, however, be extended at the discretion of the competent authority. During the period of probation, you will be required to undergo Induction Training and also to undertake other training courses and to pass such tests as the Ministry of Statistics & Programme Implementation may prescribe from time to time.
